- compliance to customer and other stakeholder requirements
- set “smart” objectives/targets and commit to continuous improvement, which is measured, evaluated and validated for effectiveness through internal and external audits and management review
- implement CAPA [corrective and preventive action]- and risk management [eg HACCP]- principle
- set up internal and external communication channels on quality and food safety culture and other aspects with employees, customers and other stakeholders to ensure all parties are informed, aware and involved.
- ensure that suppliers and contractors embrace the same quality and food safety commitments
